## OFFICIAL RULES NORDSTROM DAILY SPECIAL SCRATCH & WIN SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE NORDSTROM DAILY SPECIAL SCRATCH & WIN SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 12:00 A.M. **PRIZE/ODDS:** The prizes available in the Sweepstakes are as follows:

**GRAND PRIZE:** There will be no more than one (1) Grand Prize Winner that consists of a \$2,000.00 Nordstrom Store Gift Card. The total Approximate Retail Value ("ARV") of the Grand Prize is: \$2,000.00.
