

## Hyundai x Mubadala Citi DC Open Giveaway Official Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. WINNER MUST RESIDE WITHIN 50 MILES OF THE ROCK CREEK PARK TENNIS CENTER IN WASHINGTON, DC.**

**ELIGIBILITY:** The Hyundai x Mubadala Citi DC Open Giveaway (“**Sweepstakes**”) is open only to legal residents of the state(s) of Maryland, Virginia, and District of Columbia who are eighteen (18) years of age or older at the time of entry. Employees, officers, and directors (including their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Hyundai Motor America (“**HMA**”), The Washington Area Hyundai Dealers (“**Sponsor**”), Innocean Worldwide Americas, LLC d/b/a INNOCEAN USA, EventLink LLC, ATP Tour, Inc., the Association of Tennis Professionals, the Women's Tennis Association, and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state, and local laws, rules and regulations and void where prohibited. By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which are binding and final on matters relating to the Sweepstakes.

**TIMING:** The Sweepstakes begins at 9:00AM Eastern Time (“**ET**”) on July 27, 2024, and ends at 11:59PM ET on August 4, 2024 and consists of two (2) entry periods as set forth below.

"Grand Prize Entry Period"	07/27/2024 at 9:00AM ET - 07/30/2024 at 11:59PM ET
"First Prize Entry Period"	07/27/2024 at 9:00AM ET - 08/04/2024 at 11:59PM ET

All non-winning entries from the Grand Prize Entry Period will be rolled over to the First Prize Entry Period. Sponsor is the official time-keeper for the Sweepstakes.

**HOW TO ENTER:** Entrants may enter from one of the methods of entry as detailed below:

**HYUNDAI BOOTH ENTRY:** During the Grand Prize Entry Period or First Prize Entry Period, respectively, an eligible entrant in attendance at the Mubadala Citi DC Open (the "**Event**") may visit the Hyundai booth on site at the Event, and complete an electronic entry form on the tablet or kiosk provided at the booth, which requires the entrant to provide their full name, mailing address, daytime phone number, email address, and age range, and to answer each of the survey questions presented to submit an entry into the Sweepstakes.

**ALTERNATE MEANS OF ENTRY (“**AMOE**”):** To enter without attending the Event, hand-print your full name, full mailing address, email address, daytime phone number, and birth date on a plain 3x5 inch paper, and mail in a hand-addressed, stamped envelope to: Washington Area Hyundai Dealers Association, Attn: Hyundai x Mubadala Citi DC Open Giveaway, 1753 Pinnacle Drive, Suite 1000, McLean, VA 22102. No photocopied or mechanically reproduced entries will be accepted. No responsibility is assumed for lost, late, incomplete, illegible, misdirected or postage-due entries. Mail-in entries must be postmarked and

received prior to the end of the Grand Prize Entry Period or First Prize Entry Period, respectively.

One submission, regardless of the entry method, counts as one (1) entry into the Sweepstakes. No other method of entry will be accepted. All entries become the property of Sponsor and will not be acknowledged or returned.

**LIMIT: REGARDLESS OF THE ENTRY METHOD, THERE IS A LIMIT OF ONE (1) ENTRY PER PERSON.** No mechanical reproductions of entry forms permitted. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different identities, registrations or any other methods will void that participant's entries and that participant may be disqualified. Entries generated by a script, macro or other mechanical or automated means will be disqualified.

**RANDOM DRAWING/ODDS:**

- Grand Prize Winner Drawing: One (1) potential winner of the Sweepstakes will be selected by random drawing conducted by Sponsor on or around July 31, 2024 from among all eligible entries received during the Grand Prize Entry Period for the Grand Prize.
- First Prize Winner Drawing: Two (2) potential winners of the Sweepstakes will be selected by random drawing conducted by Sponsor on or around August 5, 2024 from among all eligible entries received during the First Prize Entry Period for the First Prize.

Subject to verification of eligibility and compliance with the terms of these Official Rules, the potential winners will be declared the official winners of the Sweepstakes (collectively, "**Winners**" and each, a "**Winner**"). The odds of winning depend on the total number of eligible entries received during the Grand Prize Entry Period or First Prize Entry Period, respectively. For the avoidance of doubt, in the event entrants win the Grand Prize they will become ineligible to win the First Prize and vice versa.

**NOTIFICATION:** Each potential winner will be notified at the email address and/or telephone number (in the sole discretion of Sponsor) provided at the time of entry (the "**Prize Notification**"). In the event that a potential winner does not respond to the Prize Notification within twenty four (24) hours of the date of issuance or declines the Prize (as defined below) for any reason, a disqualification will result, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries. Each potential winner will be required to complete and return an affidavit of eligibility, liability release, and except where prohibited by law, a publicity release form (collectively, "**Affidavit/Release**") within twenty four (24) hours following receipt of such documents. If a potential winner's notification is rejected, returned, or deemed undeliverable or a potential winner fails to execute and return the Affidavit/Release within the specified time or if he/she is otherwise ineligible to receive the First Prize or Grand Prize, as applicable, that potential winner will be deemed ineligible (even if such individual's name may have already been publicly announced), and the First Prize or Grand Prize, as applicable, will be awarded to an alternate selected at an alternate drawing from all remaining eligible entries. No more than three (3) alternate drawings may be held, after which the First Prize or Grand Prize, as applicable, will remain un-awarded.

**PRIZE:** Two (2) First Prizes: Each of two (2) first prizes shall consist of one tennis ball sleeve, each containing three (3) signed tennis balls, which shall be signed by professional tennis players participating in the Event as determined by Sponsor in Sponsor's sole discretion (each, a "**First Prize**"). For the avoidance of doubt, each First Prize Winner will only be eligible to win one (1) tennis ball sleeve.

Approximate retail value ("**ARV**") of each First Prize: \$100.

ARV of all First Prizes: \$200.

One (1) Grand Prize: The grand prize shall consist of two (2) tickets to the Hyundai Suite on August 4, 2024 for the men's and women's finals ("**Grand Prize**"). ARV of Grand Prize: \$500.

**PRIZE CONDITIONS:** All prize details shall be determined in the sole and absolute discretion of Sponsor. The actual value of a prize may vary. Any difference between the actual value and ARV will not be awarded.
